Phase 1: Concluding a Ministry Well



Calendar Year 1

Minister announces departure

February-March

Board consults with UUA transitions program manager about search timeline and process

February-March

Board reviews Settlement Handbook

February-March

Leadership and minister work together to end ministry well

Spring-summer

Interim ministry application and search

March-May

Interim ministry begins

August 1st

Phase 2: Education & Preparation for Search



Calendar Year 1-2

Board approves search budget and implements process for assembling search committee

Spring

Church website update

Spring

Search committee selection

April-June

Search committee reviews Settlement Handbook

April-June

Phase 3: Building the Search Structure



Calendar Year 2

Search committee consults with UUA transitions program manager or coach about search timeline and and process

May-August

Search committee conducts congregational survey

July-September

Search committee conducts cottage meetings/ interviews with congregation and staff

September-November

UUA offers Beyond Categorical Thinking workshop for congregation

September-December

Search committee completes congregational record in MinistrySearch system

mid-November

Phase 4: Opening Up the Search



Calendar Year 2

Searching ministers review congregational records and apply to search committees

December

Search committee has final consultation with transition coach before discernment phase of search

mid December-first week of January

Phase 5: Discernment/Mutual Selection



Calendar Year 3

Search committee receives the initial list of applicants

First week of January

Search committee conducts video interviews, reference checks, and website reviews

January

Search committee selects three pre-candidates

January

Search committee hosts three weekend pre-candidate visits

February 1-March 24

Offer date

Last week of March

Phase 6: Finalizing the Offer



Calendar Year 3

Representatives from the board and search committee finalize contract negotiations with the candidate

Late March-early April

Search committee announces the candidate to congregation

Early April

Phase 7: Beginning a New Ministry



Calendar Year 3

Candidating week ends with a congregational vote to call the candidate

Late April-early May

Preparation for the new ministry start

May-July


Beginning of new ministry

August 1st

Starting together with regional UUA staff support

August-January

If No Match Occurs: the Second Round



Calendar Year 3

Leadership and search committee decide to enter second round

First week of April

Search committee receives names for second round

Second week of April

Interviews

Mid-April

Pre-candidating weekend

Late April-May

Candidating week

Late May-June
