### 5. Vote on update to budget (Kyle)

There are three changes of significance to previously approved budget:

a. Updated income estimate resulting from appeal to congregation in January. About \$10,000 in increased pledges are reflected in the new budget

- b. Correction of error in internal communication regarding health insurance which was underestimated, added about \$5000 to spending in budget
- c. Change to a smaller copier cut lease costs starting in April.
- d. Overall the budget changed from having a deficit of \$6000 to having a surplus of \$2700 for the year.
- e. Motion by Kyle to accept the revised budget and replace the prior 2024 budget. Rob seconds the motion. Unanimous approval.

## 6. Board Communication on "closing the budget gap"

Jean asked that the results of the appeal to the congregation be communicated to the congregation. Individuals should be thanked for increasing their pledge, fulfilling their pledge, or making special gifts. Stewardship committee decided that a thank you should be signed by the board. Brian suggested making a statement in the newsletter, and something brief from the pulpit. Raeann - will work on a draft for review. Jean will work on two letters to say thank you. Rob proposes Raeann will sign the letters only.

Raeann presented a summary of opening in committees.

## 9. Statement on Alignment of activities with Church Values and Principles

The issue of aligning activities on church property vs off property was discussed. It was decided that the current policy cover church property only and that Rev Kate will consult with Council of Communities on policy for off property participation. Brian proposes to draft a further draft (6) to add a bullet and clarify that off-site events could be considered by the Council on Communities to distribute via email by a future date.
